BASIC RULES AND ELIGIBILITY

The project submitted must consist of new construction substantially completed between January 1, 2018 through December 31, 2020. Project submissions are being accepted in the following categories:

Ň	 WHO CAN PARTICIPATE?: The Excellence Awards are open to all practising engineers, architects, builders, contractors, concrete suppliers, government or public sector agencies. WHAT CONSTITUTES AN ENTRY: The project entry can be any structure, meeting the criteria of the award categories. The construction should feature at least one outstanding innovation and use of concrete as the basic building material. Only one entry per structure is allowed. 				
	SUBMISSIONS: Each entry shall consist of a duly filled in 'Entry Form'. In addition, two copies of A-4 size bound document containing 'Back-up Documentation' should also be sent. The Entry Form and List of Back-up Documentation are enclosed with this brochure. 	ASSESSMENT OF ENTRIES: All entries for the award will be scrutinised by a panel of Eminent Judges, whose decision on results shall be final and binding. The contestants shall have no claim against the panel of Judges, its members, ACI-USA or the India Chapter of ACI or its members. The Panel of Judges will consider broad parameters such as Innovative Use of Concrete Engineering Merit Architectural Merit Sustainability and Resilience while assessing each entry. The final decision about the parameters and weightage for each of them will be at the discretion of the Judges.				
\$	 PROCESSING FEE: For each entry, a processing fee of Rs. 10,000/- will be charged for handling of the entry documents and enabling the judging process. The process fee shall be paid along with the entry. 
